There were no restrictions on any Shareholders to cast votes on any of the Resolutions at the AGM and there were no Shares entitling the Shareholders to attend and abstain from voting in favour of the Resolutions accordingly to Rule 13.40 of the Listing Rules. None of the Shareholders has stated their intention in the Circular to vote against the Resolutions or to abstain from voting at the AGM.
